Due to low overhead, 92% of every dollar received goes directly to emergency assistance and items to meet basic needs During 2019, Worcester County GOLD (Giving Other Lives Dignity) provided vital emergency assistance and special programs to meet basic needs for 990 families, including 1,661 adults and 1,528 children, for a total of 3,189 individuals served.

Assist 157 families (364 children) during crisis situations and provide items to meet basic needs

Provide Backpacks filled with grade-level required school supplies for 451 children

Impact

How have your donations helped?

A grandfather taking care of his two grandchildren fell behind on his water bill. GOLD provided funds to reconnect the water.

A single mother, caring for her disabled son, received assistance to have her gas turned back on, to provide heat during the cold winter months.

After a family's house burned down, GOLD provided emergency funding and items for the children including clothing, school supplies, and toys.

A single mother took over the care of a 1 year-old after the parent was incarcerated, and found herself facing eviction. Your donations helped her and the children remain in the home.

Your donations purchased a bicycle to allow a man, who is homeless, access to a healthcare clinic.

Together, we provided a young man with a bus pass, which helped him to maintain employment. He is still employed.

After falling ill for three weeks, a woman found herself behind on her bills. GOLD paid to prevent eviction.

A single mother of two, who was homeless, was able to find employment. She needed help to secure housing. GOLD assisted with first month's rent.
